- j. Westpark Lakes detention pond rehabilitation;
- k. generators at District lift stations;
- 1. deeds, easements, appraisals, consents to encroachment, encroachment agreements, assignments of capacity, requests for service, utility conveyances, out-of-district service agreements, utility commitment letters, Phase I inspections, and conveyances of District property;
- m. storm water permitting matters, including educational materials and public comments;
- n. geotechnical survey for area between Lost Creek Detention Ponds B and C;
- o. Geographic Information System; and
- p. Fort Bend County sound wall installation project.
