- 14. Report regarding development in the District, including approve development financing agreements, amendments to development financing agreements, escrow agreements, cost sharing agreements, and consents to assignment of developer reimbursement rights.

award contracts, approve letter financing agreements, approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company, as appropriate, for the following:

- g. Fort Bend County Bellaire Boulevard right turn lane project;
- h. deeds, easements, appraisals, consents to encroachment, encroachment agreements, assignments of capacity, requests for service, utility conveyances, out-of-district service agreements, utility commitment letters, Phase I inspections, and conveyances of District property;
- i. geotechnical survey for area between Lost Creek Detention Ponds B and C;
- j. Fort Bend County sound wall installation project; and
- k. Capital Improvement Plan.
